

Members' Allowances 1 April 2008 - 31 March 2009

Please note the following:

- (i) This information is updated on a quarterly basis.
- (ii) Allowances and expenses are paid in accordance with the Members Allowances' Scheme which forms part of the Authority's Constitution.
- (iii) The allowance paid is dependant upon the role a person has within the Authority and is a set yearly amount but paid in equal monthly installments (the payment is pro rata if the role is only undertaken for part of the year).
- (iv) The basic allowance is intended to recognise the time commitment of members including calls on their time at meetings with officers, dealing with correspondence, attendance at meetings, training, conferences and workshops . It is also intended to cover incidental costs such as the use of telephones, postages etc.
- (v) The uprated or special responsibility allowances are paid to reflect the additional work taken on by some Members e.g. a committee chairman will be part of the Chair's Committee, may lead task and finish or working groups and is a member of the budget working group.
- (vi) the following allowances are included in this information: Basic allowance; Chairman & Vice Chairman of the Authority; Committee Chairman; Independent members of the selection panel dealing with the appointment of independent members; Police appeals tribunals
- (vii) Members pay income tax and national insurance, when relevant, on allowances.
